To the Board of County Commissioners of Cuyahoga County, Ohio,
and the Council of the City of Cleveland.

Gentlemen:-

The undersigned, being a majority of the free-hold electors and being also two-thirds of the legal voters in that portion of the Village of Shaker Heights, Cuyahoga County, Ohio, hereinafter described, respectfully petition your Honorable Bodies to have the following described territory detached from said Village of Shaker Heights and annexed to the City of Cleveland:-

Situated in ~~the Township of Newburgh,~~ now the Village of Shaker Heights, being parts of Original Lots, Numbers 420, 421, 412 and 413 of ~~said~~ Newburgh Township, and is further described as follows:-
beginning at a point in the center line of North Woodland Road, which point is in a line parallel with and distant 265.0 feet easterly from the center line of Rice Avenue, now known as East Boulevard;

Thence from said place of beginning northerly, parallel with and distant 265.0 feet easterly from said center line of East Boulevard to the center line of Fairmount Road;

Thence westerly, along said center line of Fairmount Road to the intersection of said center line with the southerly line of Original Lot No. 412;

Thence westerly, along said northerly line to the southwest corner of Original Lot No. 412;

Thence north 0° 23' 40" west along the westerly line of said Original Lot No. 412, 530.18 feet to a stake which bears south 0° 23' 40" east, along said westerly line, 28.96 feet from the intersection of said westerly line with the northerly line of Ambler Parkway, said stake also marking the south west corner of Cleveland Heights Village;

Thence south 73° 12' 50" east, along the southerly line of said Cleveland Heights Village to the intersection of said southerly line with the extension northerly of the easterly line of a ten (10) acre parcel of land in Original Lot No. 421 owned by A. F. Ditz;

Thence southerly along Ditz's easterly line and said line extended northerly to the center line of North Woodland Road;

Thence westerly, along said center line of North Woodland Road to the place of beginning.

Your petitioners further represent that the map attached hereto is an accurate map of the above described territory, and your petitioners hereby authorize and appoint Robert W. Adams to act as agent in their behalf in securing the detachment of the above described territory from the Village of Shaker Heights and in having the same annexed to the City of Cleveland.
