Ordinance No. 35678

AN ORDINANCE

To approve the order of the County Commissioners of Cuyahoga County, Ohio, annexing a portion of the territory comprising the Village of Shaker Heights and assessing the indebtedness of the Village thus apportioned to the City of Cleveland.

* * *

WHEREAS, the Council of the City of Cleveland, on September 3d, 1913, duly passed an ordinance annexing a portion of the territory of the Village of Shaker Heights to the City of Cleveland; and

WHEREAS, the Board of County Commissioners of Cuyahoga County, Ohio, have, upon application of the Council of the City as aforesaid, and on the written request of two-thirds of the legal voters inhabiting the territory proposed to be annexed, caused such alteration to be made and the boundaries of the City and Village respectively, to be established in accordance with the application and request; and

WHEREAS, the said County Commissioners have, in accordance with law, apportioned the existing indebtedness of the Village and all moneys and other credits belonging to the Village, which said apportionment was made in accordance with the order of the Board of County Commissioners now on file with the Council and being File No. 35113, and ordered the amount so apportioned to be paid by the parties in possession thereof to the City; and

WHEREAS, the subject matter herein provided constitutes an emergency by way of providing water and other services to the portion of the Village thus annexed to the City of Cleveland; Now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND, STATE OF OHIO;

Section 1. The order of the said County Commissioners as above described be and the same is hereby approved.

Section 2. In accordance with said order, the City of Cleveland hereby assumes as its portion of the indebtedness of the Village of Shaker Heights

the sum of Eight Hundred Twenty-Six and 23/100 (\$826.23) Dollars, which said sum shall be paid over by the Sinking Fund Commission of the City of Cleveland to the Village of Shaker Heights when annexation is complete. The said Village of Shaker Heights crediting said sum to a sinking fund and pledging said sum to the payment of the outstanding bonds assumed by the said Village of Shaker Heights in the annexation agreement with the Village of Cleveland Heights; and that the said sum shall be paid by the Sinking Fund Commission of the City of Cleveland to the Village of Shaker Heights when the Village of Shaker Heights shall have paid to the City of Cleveland out of its cash on hand the sum of Three Hundred Sixty-eight and 85/100 (\$368.85) Dollars, all in accordance with the order of the Board of County Commissioners.

Section 3. The money so to be paid by the Village of Shaker Heights to the City of Cleveland shall be collected by the Director of Finance and by him credited to the corresponding funds of the City of Cleveland.

Section 4. This ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its approval by the mayor.
